

**Higher Education Emergency Relief Fund (HEERF II and HEERF III) Report –  
Emergency Financial Aid Grants to Students**

**Quarterly Funding Report – Distribution as of March 31, 2022**

Under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), The College of Health Care Professions received education stabilization funds designated exclusively for emergency financial aid grants to students.

Pursuant to guidance issued by the Department of Education, we are providing the following information about the funds we have received, and how, and to whom, we have distributed them.

On March 31, 2021, the institution signed and returned to the Department the *Coronavirus Response and Relief Supplemental Appropriations Act, 2021 Certification and Agreement (CFDA 84.425Q) ((A)(4) Program)* required to receive funds allocated under Section 314(d)(7). The institution has used, or intends to use the total funds received to provide emergency financial aid grants to students.
  
2. On August 10, 2021, the institution signed and returned to the Department the *Higher Education Emergency Relief Fund (HEERF) III American Rescue Plan Act of 2021 (ARP) Certification Form (ARP (a)(4) ALN 84.425Q Supplemental Agreement)* required to receive supplemental funds allocated under The American Rescue Plan Act of 2021 (P.L. 117-2). The institution has used, or intends to use the total funds received to provide emergency financial aid grants to students.

7. As of this date The College of Health Care Professions has established multiple funding windows with the following eligibility requirements:
- Our initial funding window was for students that were PELL eligible for the latter of the 20/21 or 21/22 FAFSA and were active as of 7/31/21. That funding window closed 10/31/2021.
  - We opened a second funding window for students that were PELL eligible for the latter of the 20/21 or 21/22 FAFSA and were active as of 11/1/21, and had not yet received a HEERF Grant under the prior funding window. That window closed 12/31/2021.
  - We opened a third funding window for Pell eligible students for the latter of the 20/21 or 21/22 FAFSA and were active through 12/31/2021. The funding window closed on 03/31/2022.
  - Additional funding windows with similar eligibility criteria will be opened based on remaining funds.

Additionally, students may have become eligible through professional judgments, new FAFSA submissions or ISIR corrections provided they met the census date eligibility and not received a prior HEERF Grant.

8. As of this date all eligible students have been notified via email, text message and via US Mail (if their email was undeliverable) with instructions on how to contact the school to learn about their options to receive the emergency grant. Once a student contacts the school, we explain the three options on how they can choose to apply funds to their existing account balances, or have the grant sent to them directly.
